# Trio Presidency Programme

- **Action 1** – Assessing the implementation of the Territorial Cohesion objective and the Territorial Agenda 2020
- **Action 2** - Territorial Scenarios and Visions of Europe for 2050
- **Action 3** - Specific legal provisions for border areas
- **Action 4** - Systematic and structured political debate on Cohesion (General Affairs Council)
- **Action 5** - **Small and medium-sized cities**



## Common umbrella theme Action 5

- focus on metropolitan areas and regions
- about a half of the urban population in Europe lives in small and medium cities (SMC)
- SMC have their own specific capital and territorial potential
- SMC play a major role for the European territory
- Common umbrella theme of the Presidency Trio: how to better utilise the potential of SMC
- linked to the Trio Presidency assessment of the implementation of the territorial cohesion objective

# SMC in CBPR

## Concept

- The concept of cross-border polycentric regions (CBPRs) refers to the structure of polycentric networks that allow small and medium cities across borders to reach the critical mass for unlocking their development potential.

## Underused potential due to:

- Less compact settlement structure in border areas
- Peripheral location / distance to national capitals
- Diverging legal frameworks (link to Trio Action 3)

**Challenge of 'critical mass'** → cross-border cooperation

- **Setting-up/operation of joint infrastructure projects**
- **Important factors:**
  - Maturity of the cooperation process
  - Language barriers
  - Inter-personal relations
- **Challenges:**
  - Lack of long-term strategic thinking

- **Solutions:**
  - Innovative governance solutions
